

## **DECISION**

of Central Election Commission of the Republic of Azerbaijan  
on the registration of authorized representatives and authorized representative on financial  
issues of the New Azerbaijan Party in the Elections to the Milli Majlis  
of the Republic of Azerbaijan, appointed to September 1, 2024

The New Azerbaijan Party has appointed authorized representatives and authorized representative on financial issues by the Decision of the Board of Directors, dated 3 July 2024 and submitted the relevant documents for the registration of those persons to the Central Election Commission of the Republic of Azerbaijan (CEC) regarding the Elections to the Milli Majlis of the Republic of Azerbaijan, appointed to September 1, 2024.
