

DECISION

of Central Election Commission of the Republic of Azerbaijan
on the registration of authorized representatives and authorized representative on financial
issues of the Classic Popular Front Party in the Elections to the Milli Majlis of the Republic of
Azerbaijan, appointed to September 1, 2024
