DECISION

of the Central Election Commission of the Republic of Azerbaijan

on the activities related to polling stations on some election constituencies

In accordance with the Order No. 176 of President of the Republic of Azerbaijan dated June 28, 2024, early Elections to the Milli Majlis (National Assembly) of the Republic of Azerbaijan have been appointed to September 1, 2024.

To ensure the conduct of voting and the counting of votes by the Constituency Election Commissions, it is necessary to create the most favorable conditions for voters, considering the local and other conditions, while fulfilling the requirements implied in the provisions of the Election Code of the Republic of Azerbaijan (the Election Code).
