

DECISION

of Central Election Commission of the Republic of Azerbaijan
on finalizing the works concerning the determination of general results and compilation
of general election results protocol of the Central Election Commission of the Republic
of Azerbaijan in the Elections to the Milli Majlis on February 9, 2020

The voting results protocols on election constituencies regarding the Elections to the Milli Majlis of the Republic of Azerbaijan held on February 9, 2020 were compiled and submitted together with the attachment documents to the Central Election Commission of the Republic of Azerbaijan within the time and manner defined by law.

Pursuant to Article 171.2 of the Election Code of the Republic of Azerbaijan (Election Code), the documents were examined within the period defined by law.

Since it was impossible to determine voters' will on the PEC # 5 of Garadagh Con.EC # 11, PECs # 12, 19, 45, 61 of Shabran-Siyazan Con.EC # 54, PECs # 8, 13, 20 of Ujar Con.EC # 61, PECs # 3, 6, 24, 32, 42 of Goygol-Dashkasan Con.EC # 101 and PEC # 66 of Shusha-Aghdam-Khojali-Khojavand Con.EC # 124, the voting results on those polling stations shall be invalidated and the PECs of 87 polling stations shall be dismissed due to the irregularities allowed in their activity during the preparation and conduct of the elections, also during the determination of the results. Since the voting results on the other election constituencies had been determined to be accurate and documented, the works towards the examination of the Con.EC protocols and other attachment election documents shall be finalized upon taking that case into consideration.

Therefore, pursuant to Article 108.2 of the Election Code, general election results protocol of the Central Election Commission of the Republic of Azerbaijan shall be compiled.

Taking the above mentioned as a basis, pursuant to Articles 19.4, 19.14, 23.2, 28.2 28.4, 108.2 and 171.2 of Election Code of the Republic of Azerbaijan, the Central Election Commission **decides:**

1. Since through the examination regarding the voting results on the election constituencies in the Elections to the Milli Majlis of the Republic of Azerbaijan on February 9, 2020, it was impossible to determine voters' will on the polling stations the PEC # 5 of Garadagh Con.EC # 11, PECs # 12, 19, 45, 61 of Shabran-Siyazan Con.EC # 54, PECs # 8, 13, 20 of Ujar Con.EC # 61, PECs # 3, 6, 24, 32, 42 of Goygol-Dashkasan Con.EC # 101 and PEC # 66 of Shusha-Aghdam-Khojali-Khojavand Con.EC # 124, the voting results on those polling stations shall be invalidated and the PECs of 87 polling stations shall be dismissed due to the irregularities allowed in their activity during the preparation and conduct of the elections, also during the determination of the results (Appendix 1).

2. The works towards the examination of the Con.EC protocols and other attachment election documents to determine general results of the Elections to the Milli Majlis of the Republic of Azerbaijan shall be finalized.

3. Protocol of the Central Election Commission of the Republic of Azerbaijan on general results of the Elections on February 9, 2020 shall be compiled upon taking relevant decisions which had impact on the election results on election constituencies and voting results on the polling stations.

4. The decision shall be enforced upon its publication.
