

DECISION

of Central Election Commission of the Republic of Azerbaijan on the registration of authorized representatives and authorized representatives on financial issues of the Civic Solidarity Party in the Elections to the Milli Majlis of the Republic of Azerbaijan dated on February 9, 2020

The Civic Solidarity Party has appointed authorized representatives and authorized representatives on financial issues by the Decision of the session of the Board of Directors, dated 9 December, 2019 and submitted the relevant documents for the registration of those persons to the Central Election Commission of the Republic of Azerbaijan regarding the Milli Majlis Elections on February 9, 2020.
