

DECISION

of Central Election Commission of the Republic of Azerbaijan

on the registration of authorized representatives and authorized representatives on financial issues of the Azerbaijan Hope Party in Municipal Elections on December 23, 2019

The Azerbaijan Hope Party has appointed authorized representatives and authorized representatives on financial issues by the Decision of the Presidium, dated 26 October, 2019 and submitted the relevant documents for the registration of those persons to the Central Election Commission regarding the Municipal Elections on December 23, 2019.
