

DECISION

of Central Election Commission of the Republic of Azerbaijan on consideration of the appeal # 30 submitted to the Central Election Commission on January 18, 2020 in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020

In the written apply addressed to the Central Election Commission on January 18, 2020, Ahmadova Gular Mikayil, self-nominee to deputy on Yasamal second Con.EC # 16 in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020 challenged the inaction of Yasamal second Con.EC # 16 and requested to register her as a candidate and to ensure her participation in elections.

The complaint was adopted for the implementation in comply with Articles 112 and 112-1 of the Election Code of the Republic of Azerbaijan and "Instruction on the rules for filing appeals and complaints to the Central Election Commission and Constituency Election Commissions of the Republic of Azerbaijan and their consideration", relevant opinion was provided on this issue by a member of the Expert Group under CEC and considered at the Commission session upon the investigation of the appeal by the Expert Group member.

In her appeal to G.M.Ahmedova informed that she submitted her signature sheets and other election documents to the Constituency Election Commission on 10 January 2020. The constituency election commission had to make a justified decision within 7 days on whether or not the candidate was registered. By 2:00 pm on January 18, 2020, she was not informed on the Con.EC decision and was advised to wait patiently for the reply to the numerous requests.

During the investigation, the candidate was contacted and explained that he had other rights to participate in the investigation and the hearing.

The statement from the Constituency Election Commission that they mentioned in the application of the candidate in connection with the investigation indicated that the decision of the Constituency Election Commission No. 09/56, dated 09 January 2020 was denied registration of G. Akhmedova. The candidate was informed about the decision taken by the Constituency Election Commission, requested to take that decision, and a copy of the decision was sent to her by mail on January 18, 2020 (the mail is approved by the relevant postal document).

According to the above-mentioned, the legal grounds for implementing the appeal of the candidate G.M.Ahmadov were not confirmed because the inaction of the Constituency Election Commission was not confirmed and therefore, the appeal shall not be implemented by being considered groundless.

Taking the above mentioned as a basis, pursuant to Articles 19.4, 28.2, 112, 112-1, of Election Code of the Republic of Azerbaijan and item # 1,2,4,6 and 7 of the "Instruction on the rules for filing appeals and complaints to the Central Election Commission and

Constituency Election Commissions of the Republic of Azerbaijan and their consideration” the Central Election Commission decides:

1. The appeal # 30 submitted to the Central Election Commission on January 18, 2020 by AhmadovaGularMikayil,self-nominee to deputy on Yasamal second Con.EC # 16 in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020 shall not be implemented due to groundlessness.
2. The decision shall be enforced upon its publication
